List of inorganic phosphates for REACH Registration in 2013

The Inorganic Phosphates (IP) Consortium has started preparation of 2013 REACH Registration dossiers (> 100 tonnes/year).

This email is to inform you of which substances we currently do and do not intend to Register in 2013.

You should indicate to us AS SOON AS POSSIBLE if there are other inorganic phosphate substances which you need to Register in 2013 and which are NOT included in the list attached (page 2). Please specify the substance name, formula and if possible EINECS number. If you do not do this, the IP Consortium will NOT prepare for 2013, nor submit in 2013, dossiers for substances not listed below.

If you do have inorganic phosphate substances, which you need to Register in 2010 (>100 tonnes/year) and which are not on the list attached, we can discuss whether the IP Consortium can prepare a dossier for 2013 (e. g. closely related substances to those below, substances which the IP Consortium is planning to Register in 2018) or conditions to cooperate for your own dossier preparation for 2013 (read-across, data sharing ...).

If your company owns or knows of data or information relevant to the Registration of any of the substances listed (literature, studies, worker or consumer health or exposure data, other information) please make this known to us now: we remind you that it is your legal obligation under REACH to do this.

Following the present SIEF consultation, we expect to circulate by approximately May-June 2011 a final list of substances for which Registration Dossiers will be prepared for 2013 by the IP Consortium and, for each of these substances, Consortium proposals for:

- substance sameness specifications (SIP)
- covered uses and applications
- SIEF Agreement Contract text
- Lead Company for each substance
